- Vendors may set up one day only, or for the tournament's duration (Fri.-Mon.).
- B.A.S.S.'s vendor expo will officially open at 12 noon each day. Local vendors are welcome to begin selling as early as 10 a.m. Vendors will not be required to break down booth each day.
- Vendor spaces will be located at the GPC Marina throughout the weekend. However, vendors may relocate to the amphitheater area on Saturday, 6/22.
- Vendor spaces are approximately 15x15. All vehicles must be moved from the vendor area prior to the expo opening.
- **Direct sales and food vendors** must email [mnippers@cityofscottsboro.com](mailto:mnippers@cityofscottsboro.com) or call (256) 912-0520 to verify space before submitting application and payment.
- Vendor is responsible for all tables, tents, power, and water. Generators are welcome.
- Hosts will submit temporary exemption form to the health department for food vendors.
